GENERAL INFORMATION AND INSTRUCTIONS

- 1. The instructions given herein will be strictly binding on the Tenderers and deviation, if any, makes tender or tenders liable to be considered invalid. Tenders incorporating additional conditions by the Tenderer are liable for rejection.
- 2. Bids shall be submitted online at CPPP website: <u>http://eprocure.gov.in/eprocure.app</u>. Manual Bids shall not be accepted.
- 3. The instruction given in **Annexure-'A'** for **"Instruction for Online Bid Submission**" should be strictly followed during submission of the Bid.
- 4. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 5. Validity of Bids: The Bids should remain valid for 90 days from the date of opening.
- 6. Rejection of Bids: Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection. Conditional Tenders will be rejected. Non-compliance of applicable General Information and Instruction will disqualify the Bid.
- 7. The Tenderers should have Digital Signature Certificate (DSC) for filling up the Bids. The person signing the Tender documents should be authorized for submitting the online e-Tender.
- 8. The Financial Bid (BoQ) in .xls format shall be filled-in and signed by the authorized signatory online as per Proforma **Annexure-'F'** available at Central Public Procurement Portal e-Tender system website <u>http://eprocure.gov.in/eprocure/app</u>.Offline Financial Bid shall not be accepted.

In case the Bidder fails to submit any of the documents as stated above, the other part of their tender i.e. 'Cover- II' shall not be considered for further download and shall be rejected straight away without any further reference. The Technical Bids and other documents i.e. 'Cover- I' will be downloaded and evaluated at the first stage to select the technically capable and competent bidders. At the second stage, Financial/Price Bids i.e. 'Cover II' of only the technically acceptable offers will be downloaded and evaluated for further ranking before awarding the sale order. Instructions for Online Bid Submission

- The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
- 2. More information useful for submitting online bids on the CPP Portal may be obtained at https://eprocure.gov.in/eprocure/app

REGISTRATION

- Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:<u>https://eprocure.gov.in/eprocure/app</u>) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

 There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of Advanced Search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other Keywords etc. to search for a tender published on the CPP Portal.

- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- **1)** Bidder should take into account all corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/ JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To save the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- **3)** Bidder has to select the payment option to pay the EMD as applicable and enter details of the instrument.
- **4)** A standard **Price Schedule format** (BOQ) has been provided with the tender document. Bidders are requested to note that they should necessarily submit their financial bids in the specific format provided (.xls) only. If the price bid has

been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file in .xls format, open it and fill colored highlighted (unprotected) cells with the respective financial quotes and other details (such as name of the Bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

- **5)** The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 6) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the date. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/ bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 7) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- **9)** The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

GENERAL TERMS AND CONDITIONS

- Inspection of Materials at Goa Science Centre & Planetarium, Marine Highway, Miramar, Panaji-403 001, Goa, is open to intending bidders/participants of the tender from 06.03.2024 to 13.03.2024 between 11.00 AM and 05.00 PM on all working days except Saturdays, Sundays and other closed public / intervening holidays. The address furnished in the tender form shall be deemed to be that of the bidder and the correspondence sent on that shall be considered to have been delivered to the bidder.
- 2. Bidders / Tenderers are requested to quote their competitive offer/s in the enclosed BoQ and upload the same on CPP Portal and the same shall remain valid for 90 (Ninety) days from the date of opening of the tender.
- 3. Online Bid will be received up to <u>1530 Hours on 14.03.2024</u> along with <u>Earnest</u> <u>Money Deposit (EMD) of ₹20,000/- (Rupees Twenty thousand only)</u> in the form of Demand Draft / Pay Order drawn on any nationalized bank in favour of the 'NEHRU SCIENCE CENTRE' payable at 'MUMBAI' or through NEFT/RTGS (receipt to be attached). Bids will be opened at 1600 Hours on 15.03.2024. The Demand Draft of EMD shall be forwarded by the Bidder to the Director, Nehru Science Centre, Mumbai, so as to reach the same on or before up to 1530 Hours on 14.03.2024. The EMD of unsuccessful Bidders shall be refunded for which no interest will be payable. Tenders unaccompanied with EMD and incomplete offers are liable for rejection and they are not valid. Canvassing in any form is prohibited and the tenders submitted by the party who resort to canvassing are liable for rejection.
- 4. The materials will be disposed-off on AS-IS-WHERE-IS, WHAT IS and NO-COMPLAINT basis. No responsibility will therefore be accepted by Nehru Science Centre, Mumbai for the description, condition, completeness, accuracy in size, shape, nomenclature, weight, number, etc., whatsoever and no complaints will be entertained in respect of quality / quantity / condition of the items. No picking, choosing or sorting will be allowed in the Nehru Science Centre premises by the contractor.

Those participating in the tender sale will be deemed to have inspected the material before hand at Goa Science Centre & Planetarium, Marine Highway, Miramar,

Panaji-403001, Goa and thoroughly satisfied themselves with regard to the description/condition etc. of the materials under reference. No dispute in this regard will be entertained. Mis–description by Nehru Science Centre on the details of the materials due to inadvertence will not invalidate this tender sale.

- 5. For purchasing E-Waste material, <u>valid Registration Certificate from</u> <u>State/Central Pollution Control Board declaring that the firm is Registered</u> <u>Recycler / Preprocessing / Disposal of E-Waste is mandatory</u> & copy of the certificate must be enclosed with Tender Form. Certificate from State/Central Pollution Control Board must be valid on the date of Opening the Tender as well as on the day of lifting the E-Waste material. Bid without valid certificate shall be treated as disqualified.
- 6. Valid tenders will be processed for further action, after they are opened on as scheduled. The Sale Order will be issued to the Highest Quoted Bidder acceptable to Nehru Science Centre requesting them to pay total / entire bid amount by way of RTGS / D.D. in favour of Nehru Science Centre, Mumbai payable at Canara Bank, Worli Branch within eight working days from the date of Sale of Order, and thereafter lift the allotted materials concerned within 15 working days from the date of accepting of Sale Order. Copy of Sale Order duly stamped and signed should be handed over to this Centre as a token of order acceptance within seven working days of receipt of Sale Order. If Order Acceptance is not received within seven working days, it shall be presumed that Sale Order is not accepted & EMD deposited for such lot(s) shall be forfeited.
- 7. The stores will remain the property of this Centre till all the conditions are fulfilled by the successful bidder. Mere payment of money towards the allotted materials will not constitute the complete disposal. The material/s will become the property of the bidder only after the sale has/have been completed and the stores has / have been removed from the premises (i.e. Goa Science Centre & Planetarium, Marine Highway, Miramar, Panaji-403 001, Goa).
